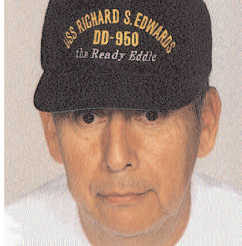

In the land of the Brave and Free.*

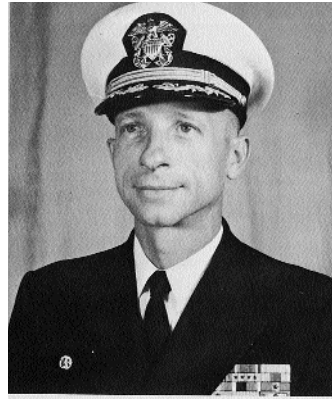
*So on this day let's lift our heads

## FAREWELL



Commanding Officer of the USS R.S. Edwards DD 950 from 1962-1964, Robert A Hogsted passed away at his home on March 29, 2002. He was born in Cornelia, GA, on October 11, 1922 and was a graduate of the Naval Academy's class of 1945. Before assuming command of EDWARDS, he served aboard four

other destroyers (Ingraham, Lyman K. Swenson, Gainard and Cony) and the aircraft carrier Lake Champlain. Prior to assuming command of the Ready Eddie, Captain Hogsted was attached to the Staff at the Naval War College.

*"He was a wonderful officer and a wonderful gentleman"*

Our shipmate Charlie Holshouser passed away on May 9, 2002. He had a service, and was buried, at Arlington. Charlie was a GMG1 who served aboard EDWARDS from 1967-1970. Charlie and his wife Marilyn were married in 1968 during his tour, leaving many special memories of the ship and crew for them both over the years. He is missed.

## What it all means.....
